One example of these are the benefits given to entrepreneurs for the purpose of developing entrepreneurship, in Uzbekistan, the social tax rate of 12 percent is set at 1 percent for several enterprises. From April 1, 2022 to January 1, 2025, a social tax of 1 percent will be paid for business entities operating in the following areas:

- Retail trade and catering
- ➢ Hotel services
- > Transportation of passengers and cargo by road transport
- Repair and maintenance of vehicles
- Computer services
- Repair of household appliances
- Provision of agro and veterinary services
- Providing services in entertainment establishments

The privilege is applied to business entities if their income at the end of the current reporting period is at least 60% of their total income.

Analysis of literature on the topic. Scientists systematically conducted research on the implementation of international standards in enterprises and the increase of storage warehouses. In particular, among the scientists of our country, K.B. Urazov, M.E. Pol'latov, S.N. Tashnazarov, H. Irgashev, I. Akhmadkhanov and other economists of ours conducted scientific research on the issues of using international standards and improving their reflection in the form of claims and supplements and financial reports.

Taking these into account, using the Internet and world political information, proposals were made to improve the standard of living of the population, develop entrepreneurship and expand the economy.

Analysis and results. If it is discovered that the number of employees has been hidden by business entities performing the listed types of activities, the benefits will be suspended and financial penalties established by law will be applied. Apart from that, the proposal to reduce the VAT tax from 15% to 12% from January 1, 2023 was also mentioned. Of course, in response to these benefits, entrepreneurs are finding innovations and changes in every aspect of business. In accordance with the decision of the President of the Republic of Uzbekistan "On additional measures for the transition to international standards of financial reporting" dated February 24, 2020 No. from the end of 2021, individuals must prepare financial statements based on international standards of financial reporting (hereinafter referred to as "IFRS") and provide accounting services with at least three specialists with relevant certificates within the framework of international certification until the end of 2021, and the decision provides for enterprises to conduct accounting in accordance with international standards holds.

Institutions of higher education should introduce updated educational programs in the educational process, which provide for in-depth study of MIS in the subjects of "Accounting" and "Audit", ensure that pedagogues in these subjects are trained in MIS in accredited educational centers, and from the 2021/2022 academic year, experience-test higher teaching accounting and auditing subjects in educational institutions only by teachers who have the appropriate certificate within the framework of international certification.

During the years 2020-2025, teaching personnel of higher education institutions (on the subjects of "Accounting" and "Audit"), students, graduates (within six months after graduation) and employees of state bodies in accredited educational centers will be trained in MIS, as well as training them as accountants. The fact that the costs of initial registration and examination registration in the Republic of Uzbekistan within the framework of international certification will be covered from the budget of the Republic of Uzbekistan and other sources not prohibited by legislation is a sign of strong attention to this field.

The temporary regulation on the procedure for reimbursement of the costs of passing exams within the framework of training and international certification of accountants according to the international standards of financial reporting, which provides for the following, is approved in accordance with the appendix.
